

 - Pedestrian improvements stalled
- 2. Chipping Barnet Community Plan
 - May Initial projects commented on by Robin, Gail, Andrew, Simon C & Simon W
 - 17 August 28 September Online public exhibition of possible projects
 - BSoc review panel?
 - End September Selection of five projects for detailed study (LBB & CBTT)

Planning policy

- 3. UK planning system
 - Government has loosened planning controls further. No permission required to
 - o change use between e.g. retail, café or office
 - o change use from wider range of commercial buildings to residential
 - demolish and rebuild vacant or redundant commercial/residential buildings for homes
 - build additional space above property (subject to neighbour consultation)
 - Comprehensive reform of system to speed up building
- 4. London Plan Government demanding amendments, e.g. on social housing
- 5. Hertsmere Local Plan

Draft to be published imminently. Likely to include new housing on Green Belt:

- on farmland N-E of Borehamwood and S of Potters Bar as far as the M25
- on farmland N-W of South Mimms, new Rabley Green & Redwell "garden villages"
- two sites at Ganwick Corner (near The Duke of York pub on the A1000)
- Sky studios N-E of Borehamwood (2,000 jobs on 32-acre site)



6. <u>Probable restructuring</u> Motivated by

- Big budget deficit
- Reduce Sadiq Khan's budget and influence
- 7. <u>384 bus</u> Theresa Villiers MP leading campaign against re-routing
- 8. <u>High Barnet Station developments</u> 292 flats on adjoining land Planning application expected any time
- 9. <u>Cockfosters Station development</u> 351 flats on adjoining land Planning application expected this month or early next
- 10. Finchley Central Station 560 flats on adjoining land including 20-storey tower
- 11. <u>Woodside Park Station</u> 86 flats on adjoining land Approved in January
- 12. <u>Arnos Grove Station</u> 162 flats on adjoining land (see below) Decision awaited



Other planning decisions awaited

- 13. <u>Victoria Quarter</u> 652 flats on gasworks site 935 comments submitted: 910 opposed (including BSoc), 23 in favour
- <u>Whalebones Estate</u> 152 homes BSoc objected last summer. May go to Committee this summer. May be awaiting government approval or amendment of London Plan
- 15. <u>Kingmaker House</u> 145 flats Gone to appeal
- 16. <u>Gas peaking plant, Partingdale Lane</u> In Green Belt on land adjacent to existing National Grid sub-station

- 17. <u>17 Park Road</u> 7 flats on 2 floors of former offices (6th try)
- 18. 2 Bruce Road 8 rooms in HMO
- 19. Heather Cottage, Hendon Wood Lane new Neo-Georgian mansion

- 21. <u>50 St Albans Road</u> Enterprise Rent-A-Car. RIP pub sign (below)



New application

- 22. 151-153 High Street (former car showroom)
 - Restoration of two buildings, one Grade II listed (on left in photo below)
 - Proposed retail unit, 3 flats and 3 houses (behind)



Ongoing enforcement cases

- 23. <u>70 High Street</u> Roof being built significantly higher than approved
- 24. <u>1 Sunset View</u> Builder continuing to mutilate locally listed building
